Due to Top Urgency, GFTO announces its desire to export quantity/100.000/ tons of barely from General Establishment for Fodders Hasaka production

Bid Bond:

-The bidder should submit a Bid bond of /100.000 Euro/ for the whole quantity or at rate of /1 Euro/ per ton in case of submitting partial offer..

-The bid bond has to be paid in cash by either a banking transfer or a duly certified Cheque.

-The bid bond should be issued by the Commercial Bank of Syria Damascus, or by any of the licensed private banks in Syria, in favor of GFTO to reach us latest at 15.20 Hrs. on Tuesday 23/6/2020, valid until 23/9/2020, (Every bid bond is contrary to that, the offer will be rejected).

- Bid bond should be submitted exclusively by the bidders.

-If it is not possible to submit the bid bond by the bidders, their agent in Syria can submit it in Syrian

Pounds.

<u>Prices</u>: should be quoted in Euro per Ton on basis warehouses of General Establishment for Fodders –Hasaka branch.

<u>Performance Bond:</u> 10 % of the total value of the contract.

Shipment & delivery Period: Buyer has to receive the material from the warehouses of General Establishment for Fodders- Hasaka branch- within two months from the date of receiving the workable documentary L/C by the GFTO or from date of delivering the commencement order to the buyer.

-The bidder should keep bound to his own offer for /60 days/ at least from the latest date for submitting offers. The awarded bidder should commit to his offer for /60/ days starting from the day following date of notifying him confirmation in writing or by fax and that offer is awarded to him.

-Delivery Delay Penalty:

1--If the settlement is by a documentary L/C:

The contractor will be fined with a delay penalty (if he is responsible for the delay) at rate of one per thousand per each day of delay of the value of the quantities which have been shipped outside the contractual period specified by two months for the whole quantity from the date of receiving the workable documentary L/C by GFTO, but provided not to exceed 20% of the total contract value, even if no damage is caused to GFTO and even if the seller and the buyer agreed to extend delivery period for an additional period.

2-If the settlement is by a banking transfer:

The contractor will be fined with a delay penalty (if he is responsible for the delay) at rate of one per thousand per each day of delay of the value of the quantities available and ready for delivery till settling their value. The delay penalties will be calculated after passing a period of working seven days from the date on which the buyer is asked to settle the value of the quantities available and ready for delivery till settling their value, but provided not to exceed 20% of the total contract value, even if no damage is caused to GFTO and even if the seller and the buyer agreed to extend delivery period for an additional period.
